

Terms and Conditions

1. These terms and conditions together with any specific rules set out in Qualifying Submission (as defined below) are the Entry ("**Rules**") and apply to submission of sketches to the ALIVESHOOES.COM website. By submitting a sketch entrants agree to be bound by these Rules.
2. Business Revolutions 2.0 reserves the right to cancel or amend the Rules without notice. Any changes will be posted either within these terms and conditions or the About Us section of the website.
3. Business Revolutions 2.0 will determine the selection of sketches based upon the following criteria: Total number of votes received, Creative concept, Cost and Feasibility of creation. It is important entrants provide a detailed description of their concept during the submission process.
4. Timing of the selection of sketches is at the discretion of Business Revolutions 2.0
5. In the event of any dispute regarding the Rules, conduct, results and all other matters relating to the submission and process of selection of sketches to be produced as finalised artworks, the decision of Business Revolutions 2.0 is final and no correspondence or discussion shall be entered into.

Qualifying Submission

1. All sketches submitted must be your own work and shall not be a copy, plagiarism or reproduction of another persons work. By submitting a sketch you confirm this is an original idea and is not property of another person or organisation.
2. The address you provide with your competition entry ("**Entry**") may be used in correspondence so please make sure this is correct.
3. Employees of Business Revolutions 2.0 or any associated company of Business Revolutions 2.0 and their immediate families, persons connected with the submission and artwork creation process and their immediate families are not eligible to submit work.
4. By submitting a sketch, you hereby warrant that all information submitted by you is true, current and complete. Business Revolutions 2.0 reserves the right to verify the eligibility of all entrants.
5. Business Revolutions 2.0 assumes that by reading this publication or by using the website and submitting a sketch (and you warrant that) you are aged 18 or over or, if you are under 18, that your parents have consented to your entry into the submission process and these Rules.
6. Business Revolutions 2.0 reserves the right to disqualify any entrant if it has reasonable grounds to believe the entrant has breached any of the Rules.
7. In the event that any entrant is disqualified from the submission process, Business Revolutions 2.0 in its sole discretion may decide whether a replacement should be selected. In this event, any further entrant will be selected on the same criteria as the original entrant and will be subject to these Rules.

8. Only one entry per person per is allowed.
9. Where a submission has been selected and Business Revolutions 2.0 discovers or has reasonable grounds to believe the entrant has made more than one Entry, Business Revolutions 2.0 reserves the right to select an alternative submission. Any further submission will be selected on the same criteria as the original submission and will be subject to these Rules.
10. There is no purchase requirement to submit a sketch.
11. When a sketch is selected by the judges the entrant will be notified and Business Revolutions 2.0 will enter into discussion with the entrant to, where possible, make arrangements for transportation, accommodation and facilitation to enable production of the artwork. If for any reason Business Revolutions 2.0 are not able to provide either in part or whole, transportation, accommodation or facilitation, the entrant will be asked to fulfil this responsibility at their own cost. Business Revolutions 2.0 will decide if and when any reimbursement for costs incurred will be made.
12. Entrants who's sketch has been selected for creation will receive a pair of ALIVESHOOES used within their artwork
13. Entrants who's sketch has been selected for creation will receive 10% of the ALIVE VALUE created from sale of the shoes used within their artwork. The ALIVE VALUE will be calculated by Business Revolutions 2.0 after 6 months of the shoes being made available for purchase and entrants will be informed of this value. This will constitute a single payment and no further payments will be made.
14. Entrants will need to ensure they have both personal and travel insurance in place in event of any accident or injury which may occur during their time with Business Revolutions 2.0 and in production of artwork.
15. Entrants should note that unless stated otherwise, Business Revolutions 2.0 does not accept responsibility for the return of any Entries, including those consisting of artistic or other material
